PROMOTION PERIOD: The Bubba Gump Summer Concert Tour Sweepstakes (the "Sweepstakes") starts at 12:00 a.m. Eastern Time ("ET") on March 11, 2019 and ends at 11:59 p.m. ET on September 9, 2019 ("Sweepstakes Period")
